I warned the proud, "Stop your boasting!" I told the wicked, "Don't raise your fists! Don't raise your fists in defiance at the heavens or speak with such arrogance." The news came out on Sunday July 25 that there was rebellion in the ranks of the Wagner Group, led by Yevgeny Prigozhin, popularly known as "Putin's chef." Suddenly on July 24, 25, he and his men were like "mad Jehu" (2 Kings 9) driving toward Moscow. What must be in their minds? Overthrow of the government? Attacking the government? Attacking Putin? Then, just as suddenly, we read that the Wagner group had stopped. Furthermore today, the media doesn't know where Prigozhin is. The whole scenario has the appearance of many several surprising and exciting chapters yet to come.

Yet, God is not surprised. He knew in advance how Pharaoh would respond when Moses and Aaron appeared on his doorstep. He well knew the heart of pagan Nebuchadnezzar; but He also knew how He could humble this proud king. He also knows how to handle kings, potentates, prime ministers, and presidents today. Remember this: the Lord Jesus told us, "You will hear of wars and rumors of wars; but see to it that you are not alarmed. Such things must happen; but the end is still to come" (Matthew 24:6). God has not, nor will not abdicated His Throne! Do you find your becoming alarmed because of current events, take it to the Lord. Trust Him to exert His sovereign will.

Resident Rights

- * Right to examine results of the three most recent years of survey of facility conducted by Federal or State surveyors and any plan of correction in effect with respect to facility including routine re-surveys, complaint surveys, and life safety surveys
- * Right to receive information from agencies acting as client advocates and be afforded the opportunity to contact these agencies
- * Right to choose or refuse to perform services for facility and facility will not require a resident to perform services for facility
- * Right to send and receive unopened mail and to receive unopened, letters, packages and other materials delivered to the facility for the resident through a means other than a postal service
- * Right to communicate with individuals and entities within and external to the facility, including reasonable access to internet, stationery, postage, writing implements and ability to send mail
- * Right to privately receive visitors of his/her choosing at time of his/her choosing subject to resident's right to deny visitation when applicable, and in a manner that does not impose on the rights of another resident
- * Right to form and participate in Resident Council and family and representative have the right to form and participate in Family Council to discuss issues and concerns about the facility's policies and operations
- * Each resident has the right to have family member and representative to be involved in the care of the resident and in the life of the facility including inspection of the resident's medical record with signed approval of the resident
- * Facility will allow representative of Office of State Long-Term Care Ombudsman to examine resident's medical, social, and administrative records in accordance with State law
